Grand Master Kim, is pleased to announce that the 2010 Kim's Taekwondo Challenge will be held on Saturday, January 23, 2010 in Regina. Kim's Challenge is an excellent opportunity for new and returning competitors to test themselves and watch some highly competitive fights.

Cho Dan Bo students who are newer to competition or new to black belt can spar with the colour belt division with gups one and two. If you choose to have the competitor compete in the colour belts please have the competitor fill in the colour belt form and put Cho Dan Bo as their rank/gup.

Executive Division: We will also be having an executive division for Adults that are 40 years of age and up. This division will run if we have enough registrations.

Recreational Division: Once again this year we are going to try a recreational division (based on registration). If you have students who are relatively new black belts who *have not and will not* be working toward competing at the national level, we would like to have a "recreational division" division with no head contact. This would be ideal for those teens and adults who have just gotten their black belts and are not experienced fighters. IT IS IMPERATIVE that instructors screen who goes into this division --we do not want a 20-something former national competitor who took three years off to decide that they don't want head contact and enter this division. This would definitely be categorized as a NOVICE level sparring division for black belts 14+.

We invite you and the members of your schools to come to Regina for a day of fun, fair competition and great hospitality. All divisions will be made up according to age, weight, and belt rank to ensure fair and challenging competition.

All fight divisions will be double elimination ensuring multiple opportunities to compete in the ring. Poomse should be demonstrated to the competitors gup or dan rank.

Enclosed is a schedule of events, accommodation and contact information, and application forms.

We hope that your school will come help and make the 2010 Kim's Taekwondo Challenge a success.

Rules: Current WTF Competition Rules will be in effect. Head contact applies to Black Belts, 13 yrs and older only. Executive Division has no head contact.

Equipment: All protective equipment (chest protector, arm and shin guards, groin protector, and mouthguard) is mandatory and must be supplied by the competitor. No exceptions.
***Please note: competitors may be asked to exchange headgear in order to avoid conflict with colour of chest protector.*

Matches: Coloured Belts: two 90 second rounds.
Black Belts: two 2 minute rounds and 3 two minute rounds for finals.

We will be having double elimination for all divisions. That means that everyone will be offered at least two matches. In smaller divisions this may mean that you compete against the same competitor more than once. This will assist the instructors and athletes in their goals to acquire experience for the developing athletes.

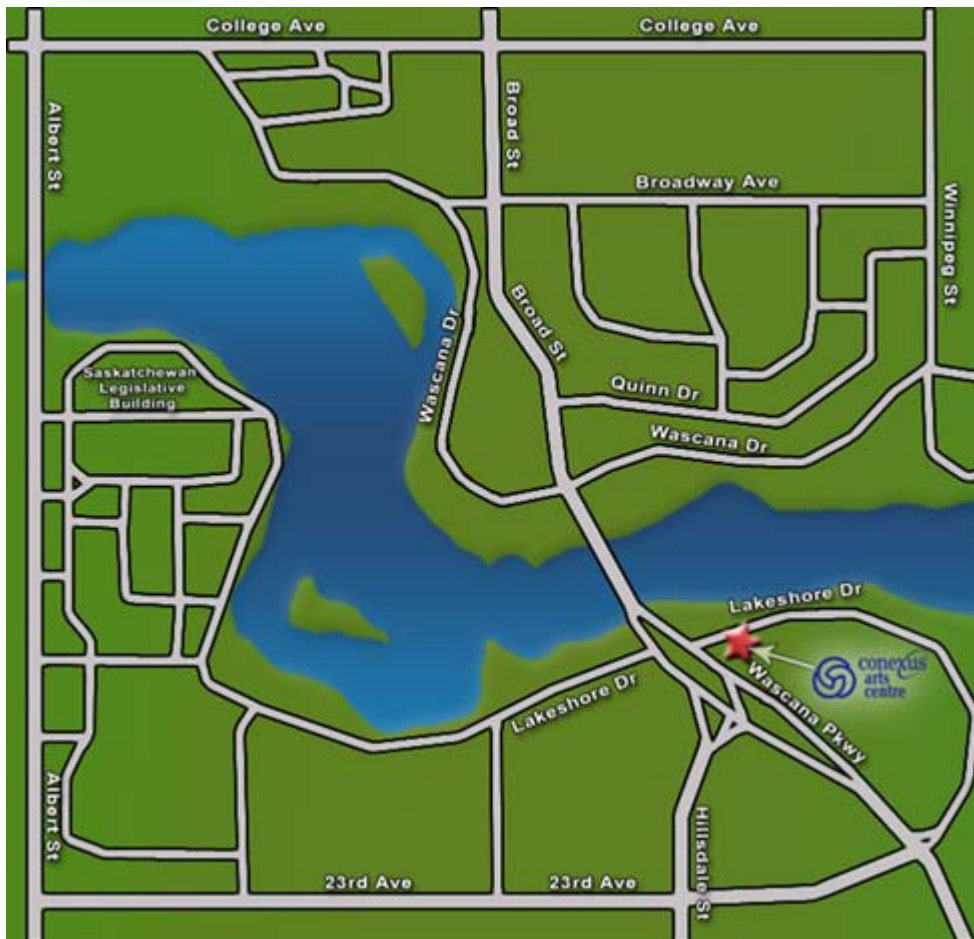
